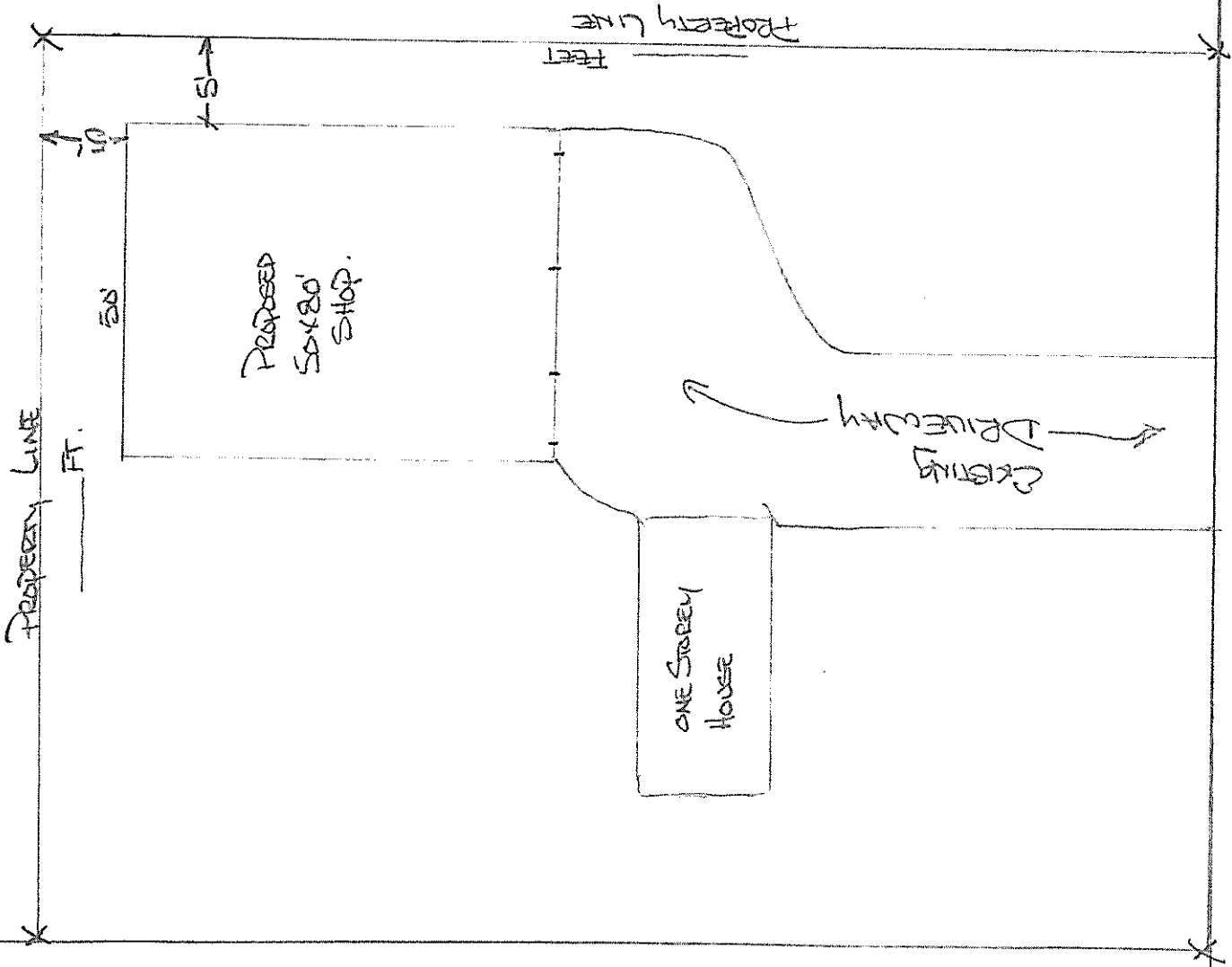

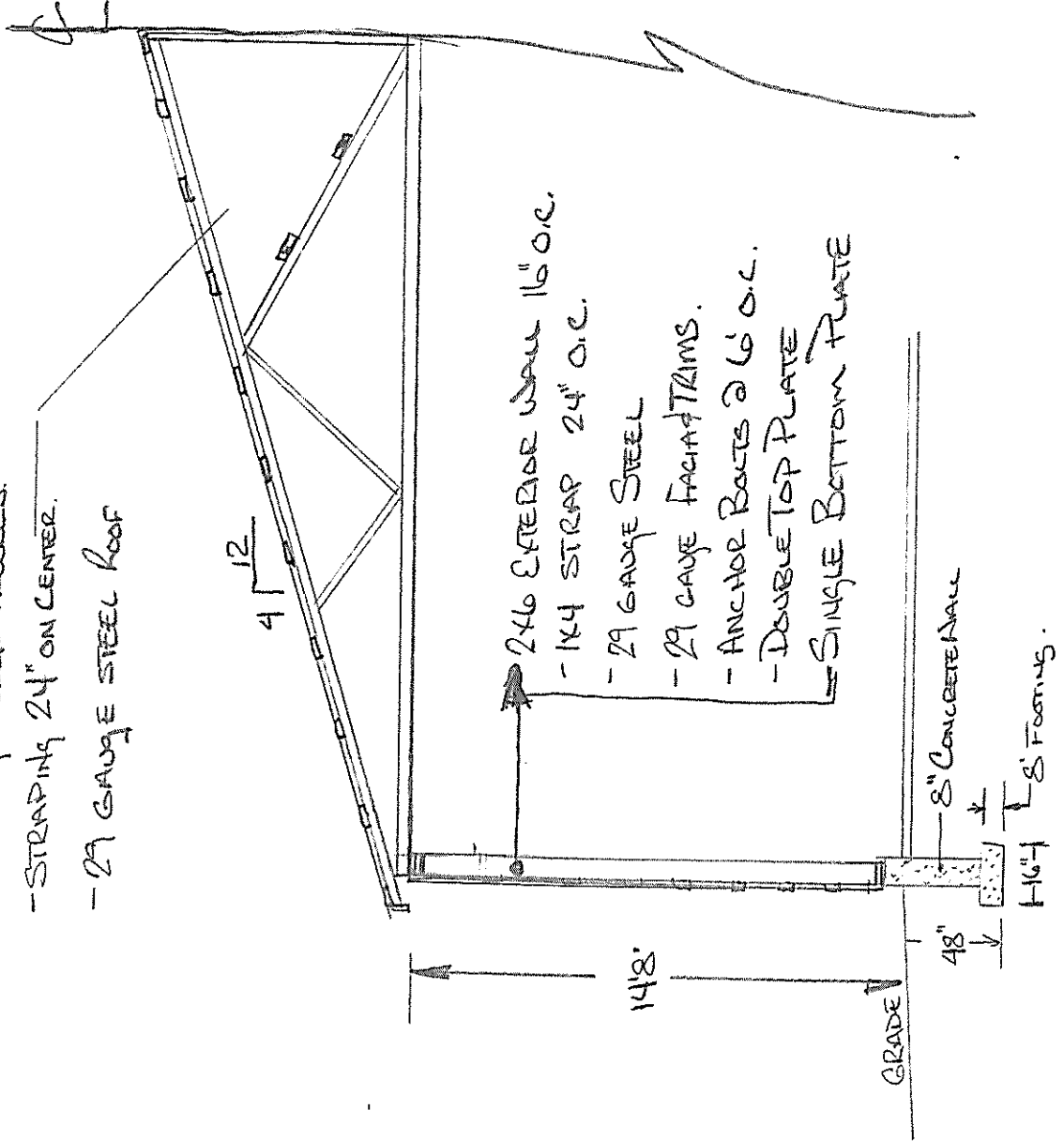

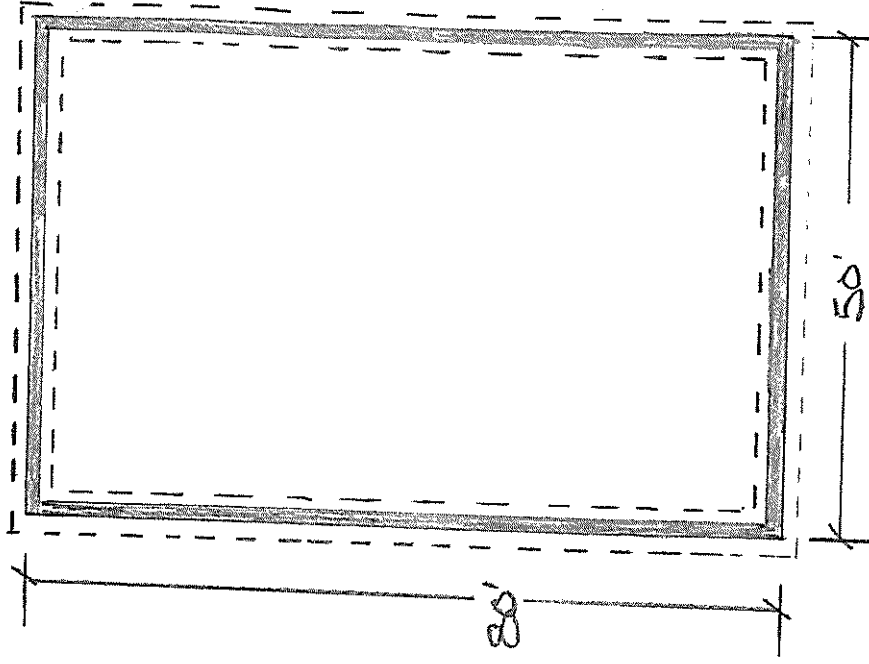

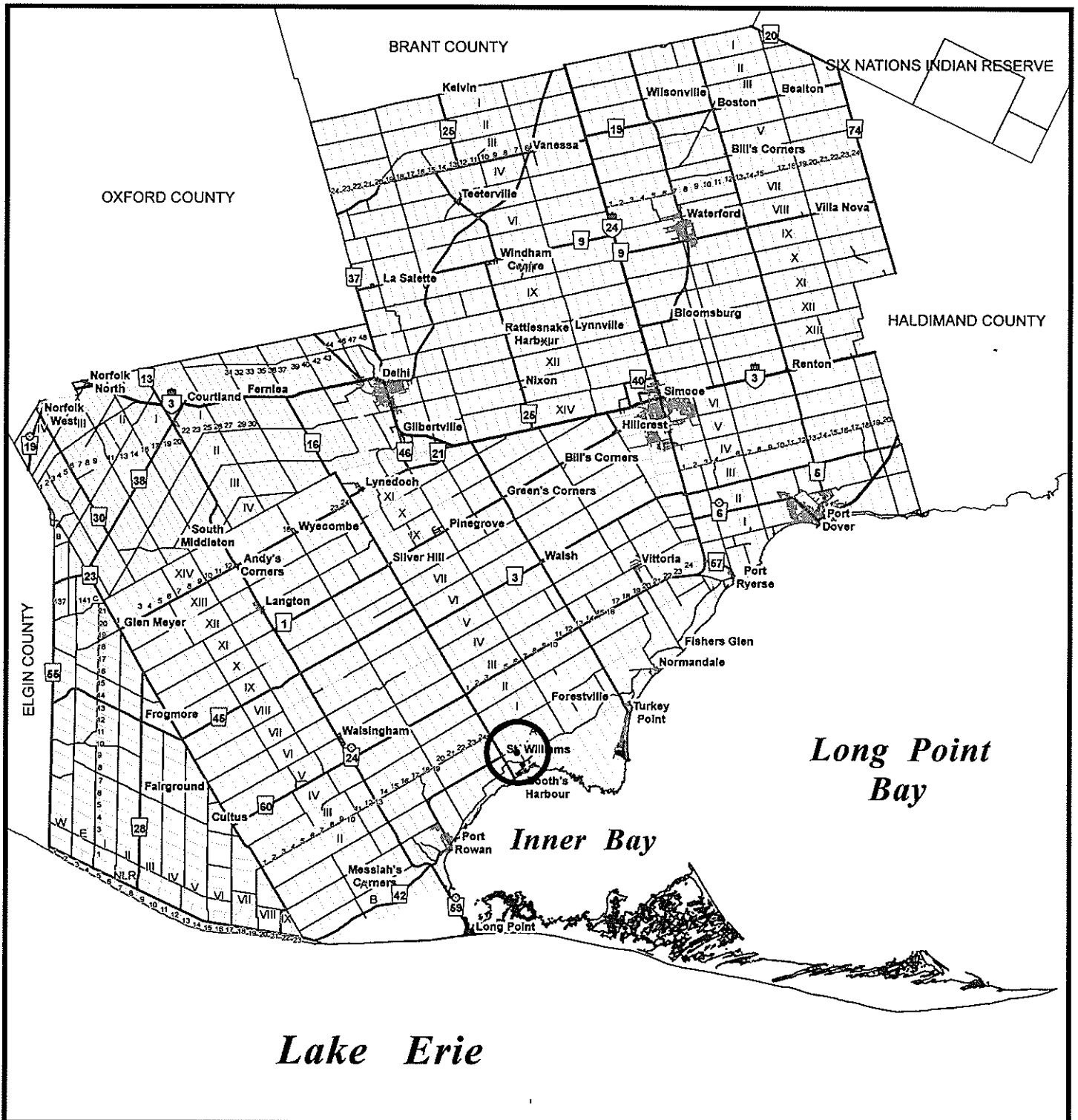
FOUNDATION PLAN VIEW

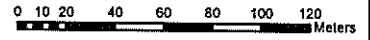
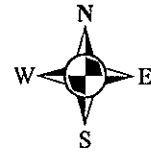

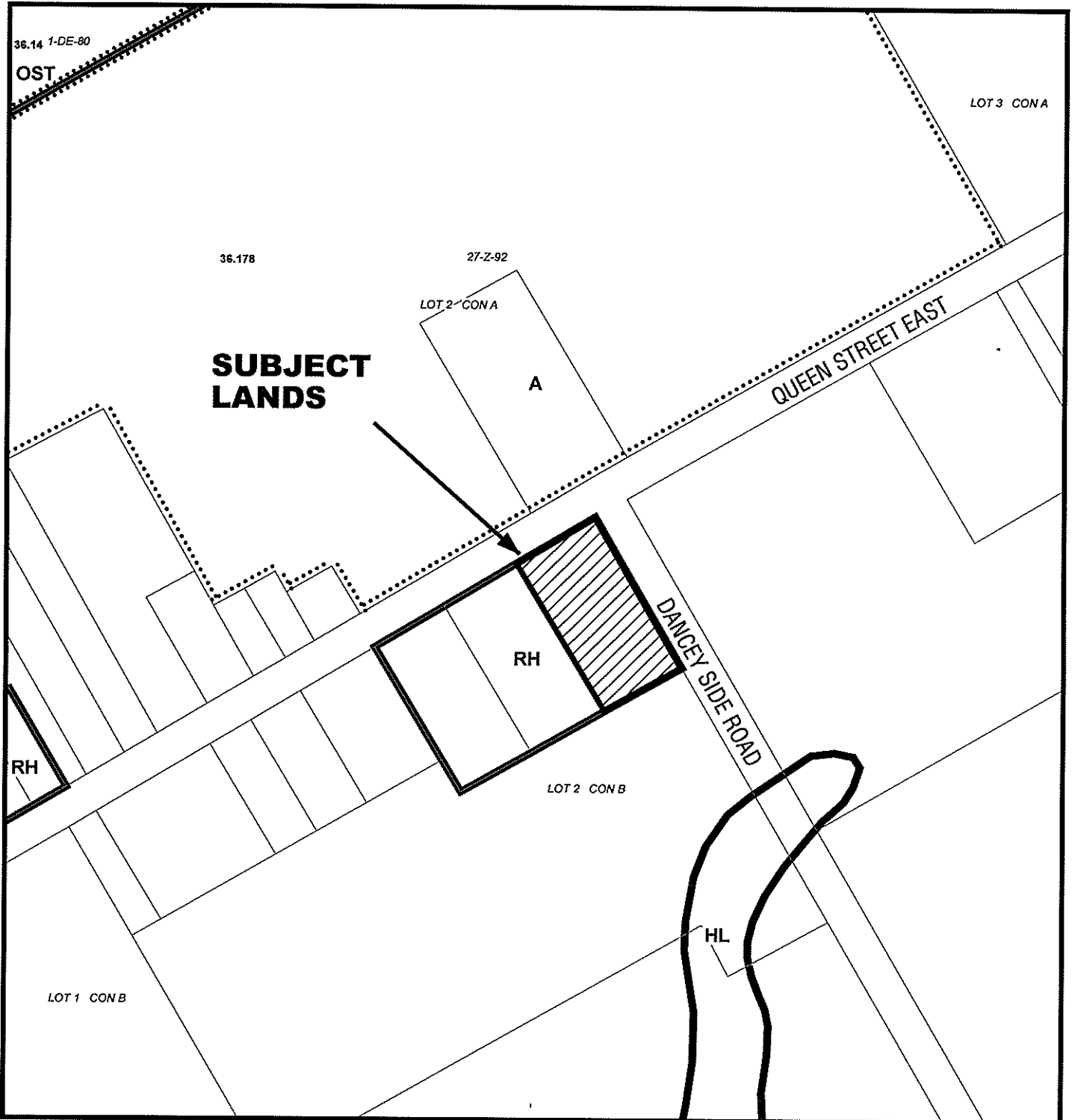
MAP 2

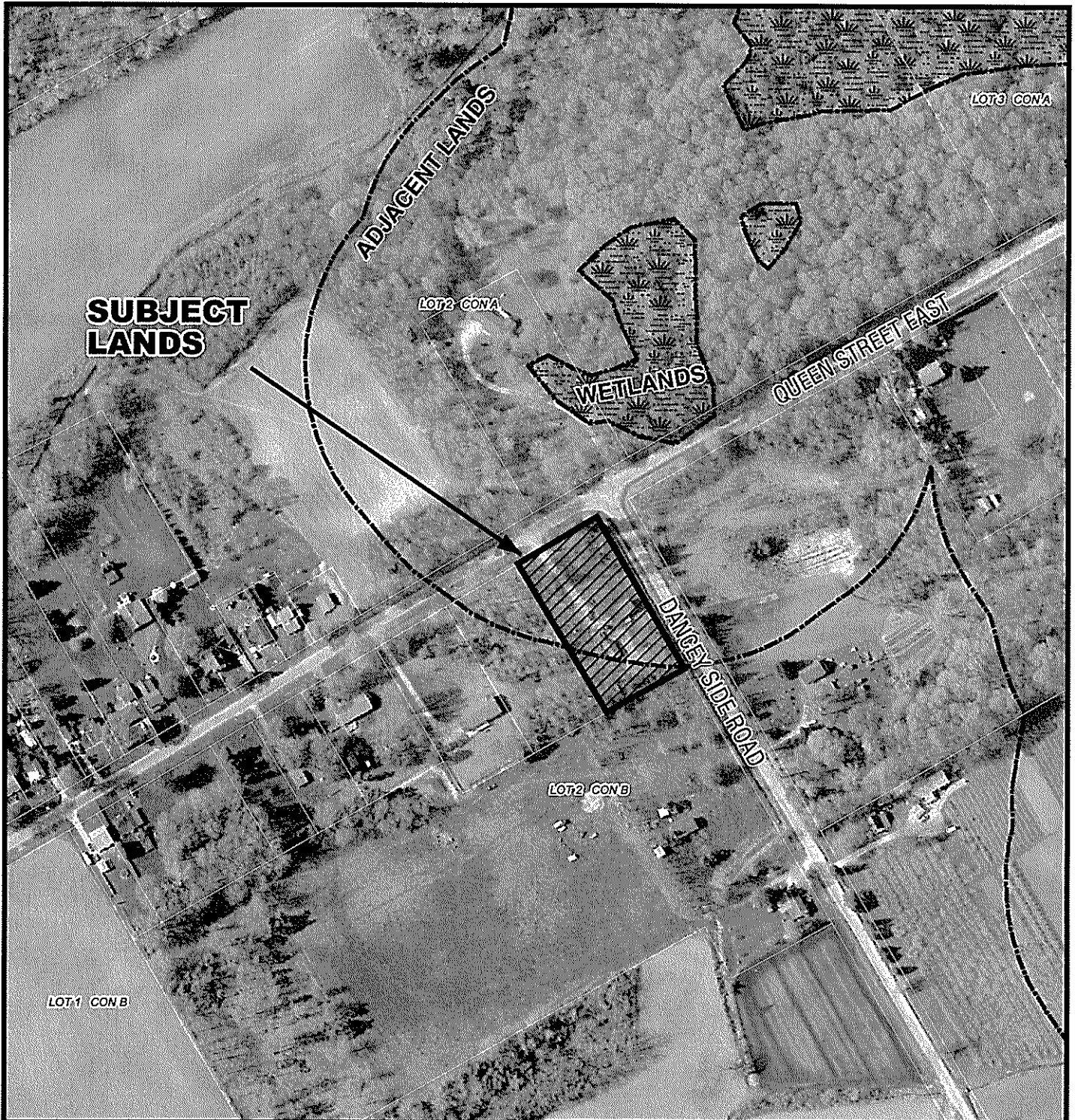

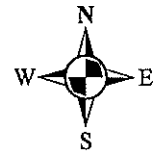
