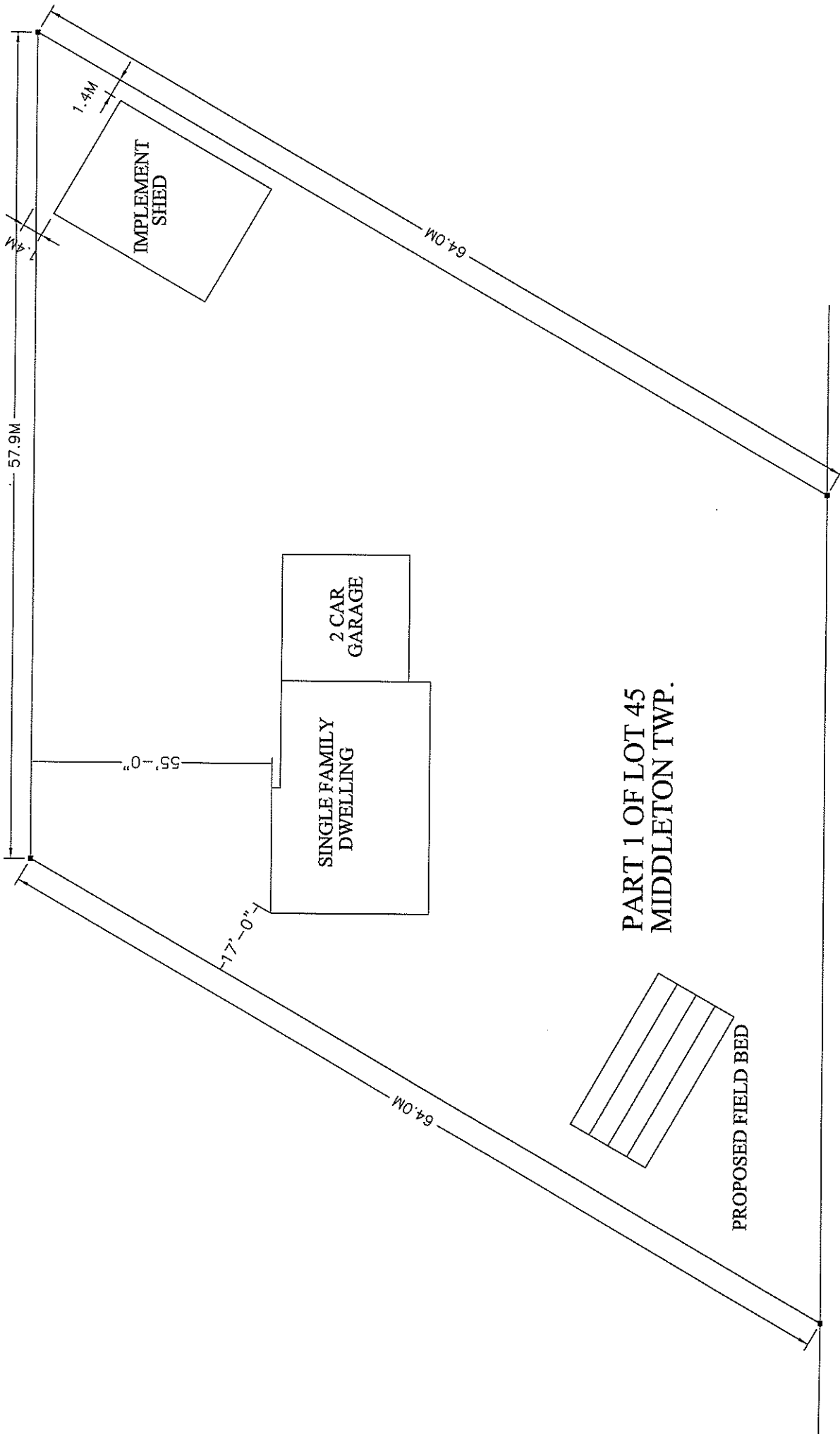

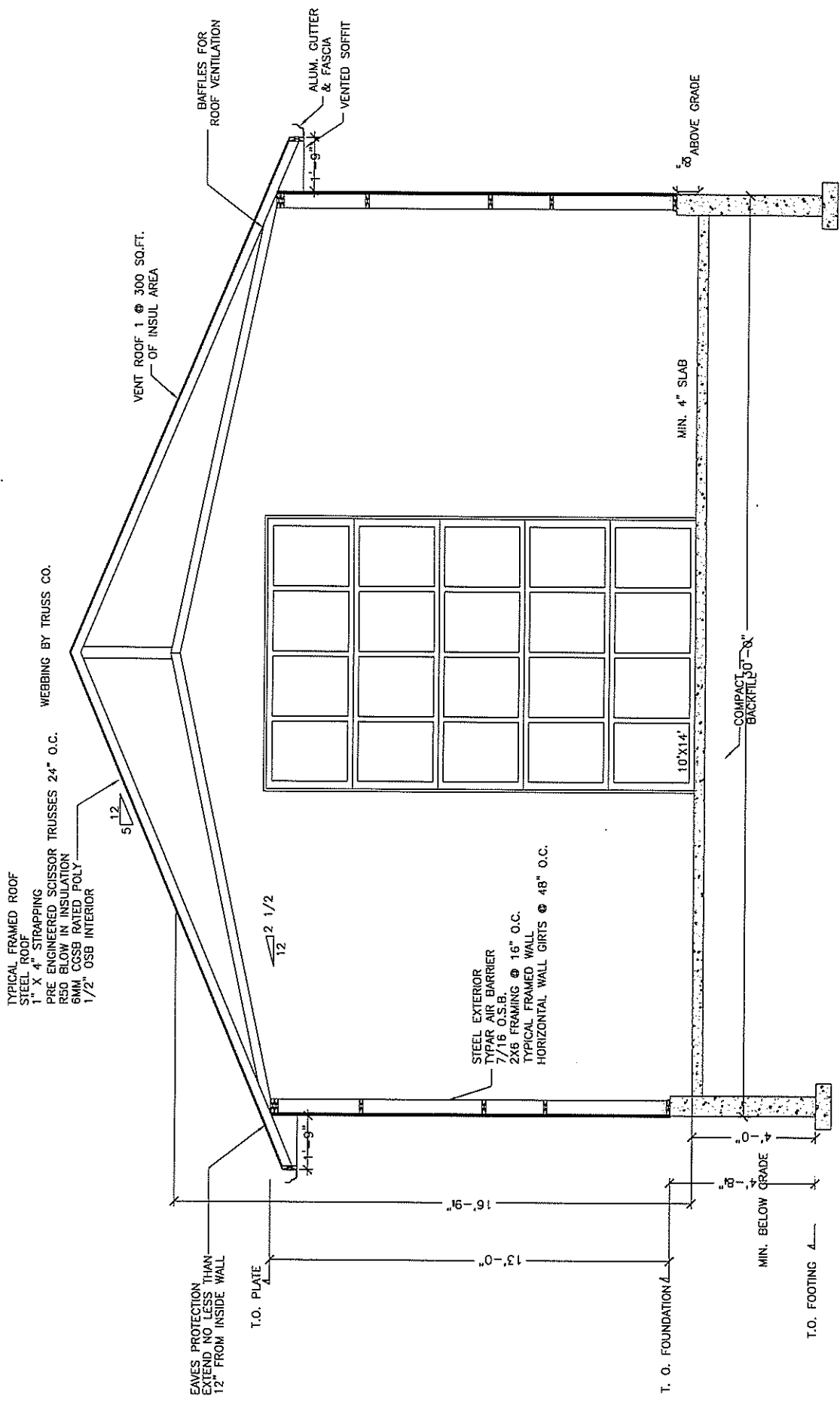

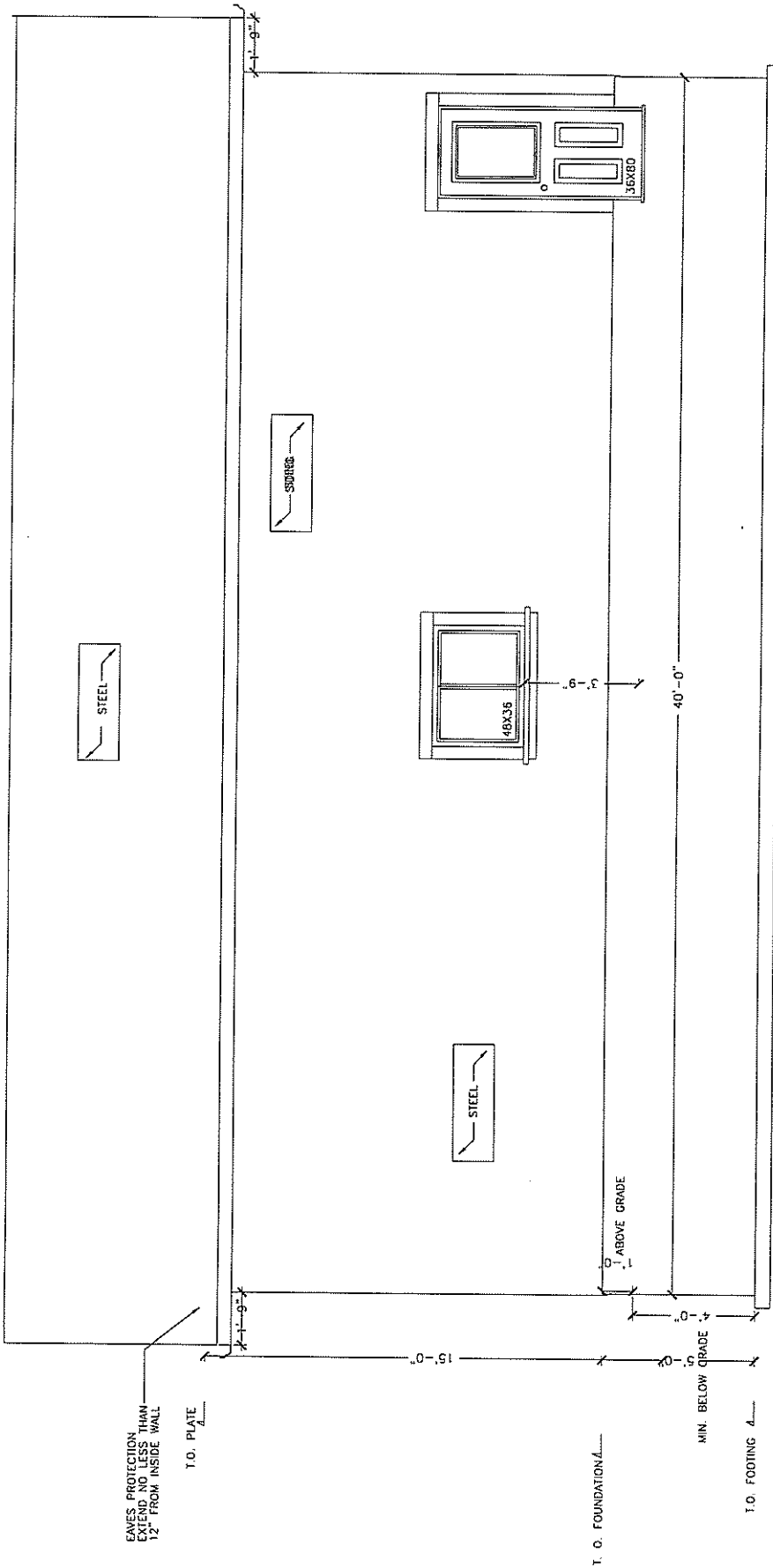


PART 1 OF LOT 45

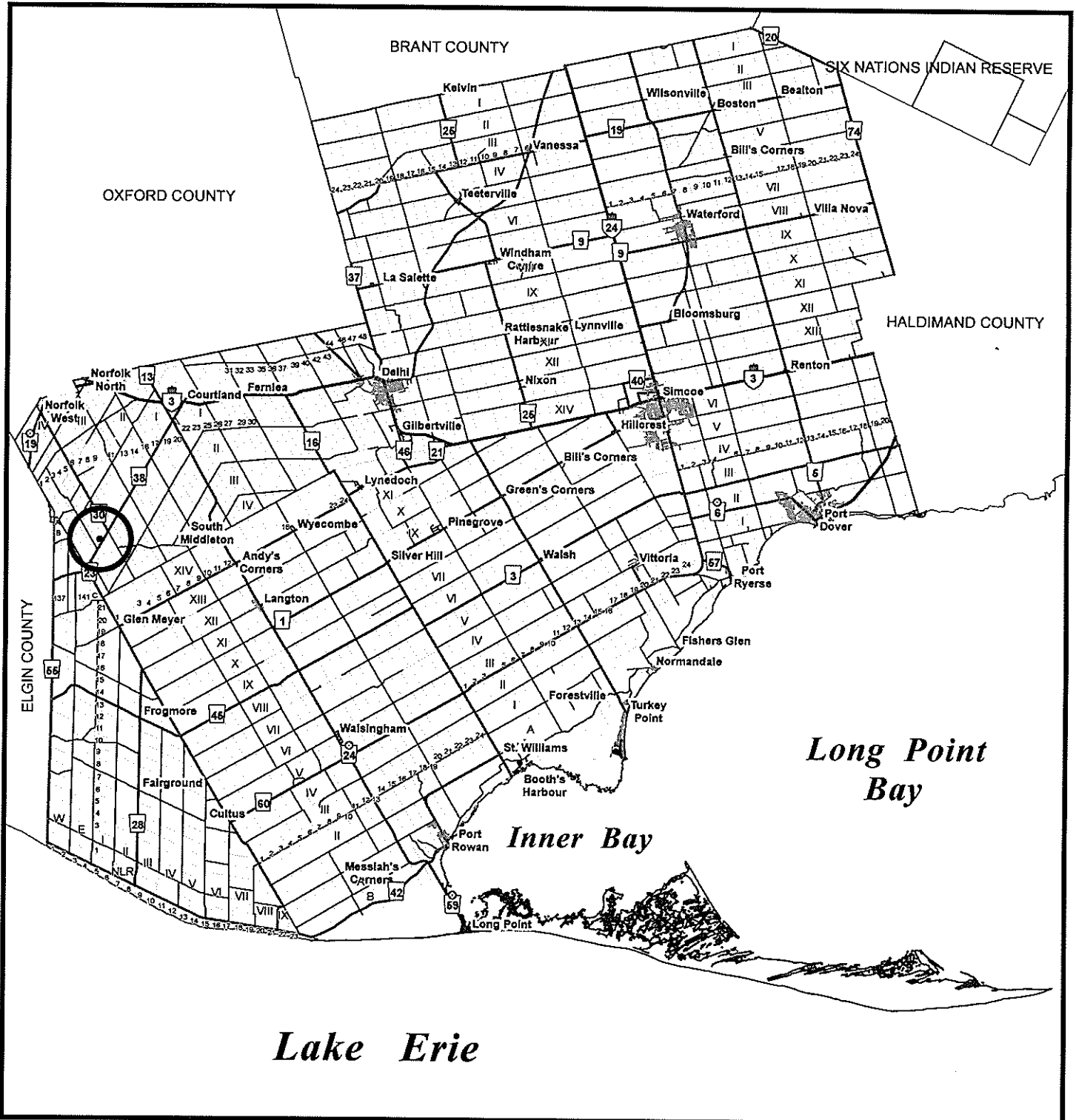

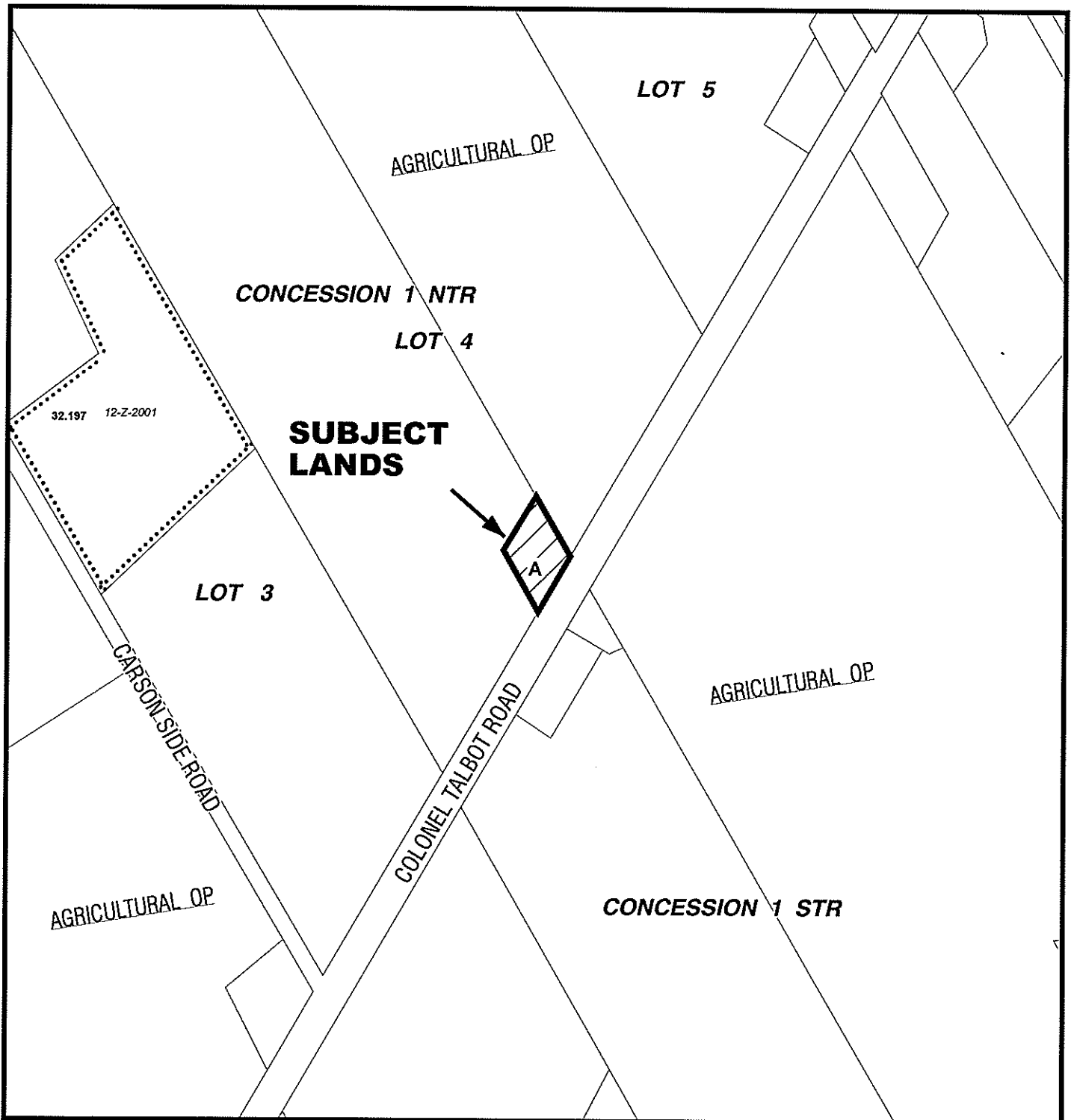

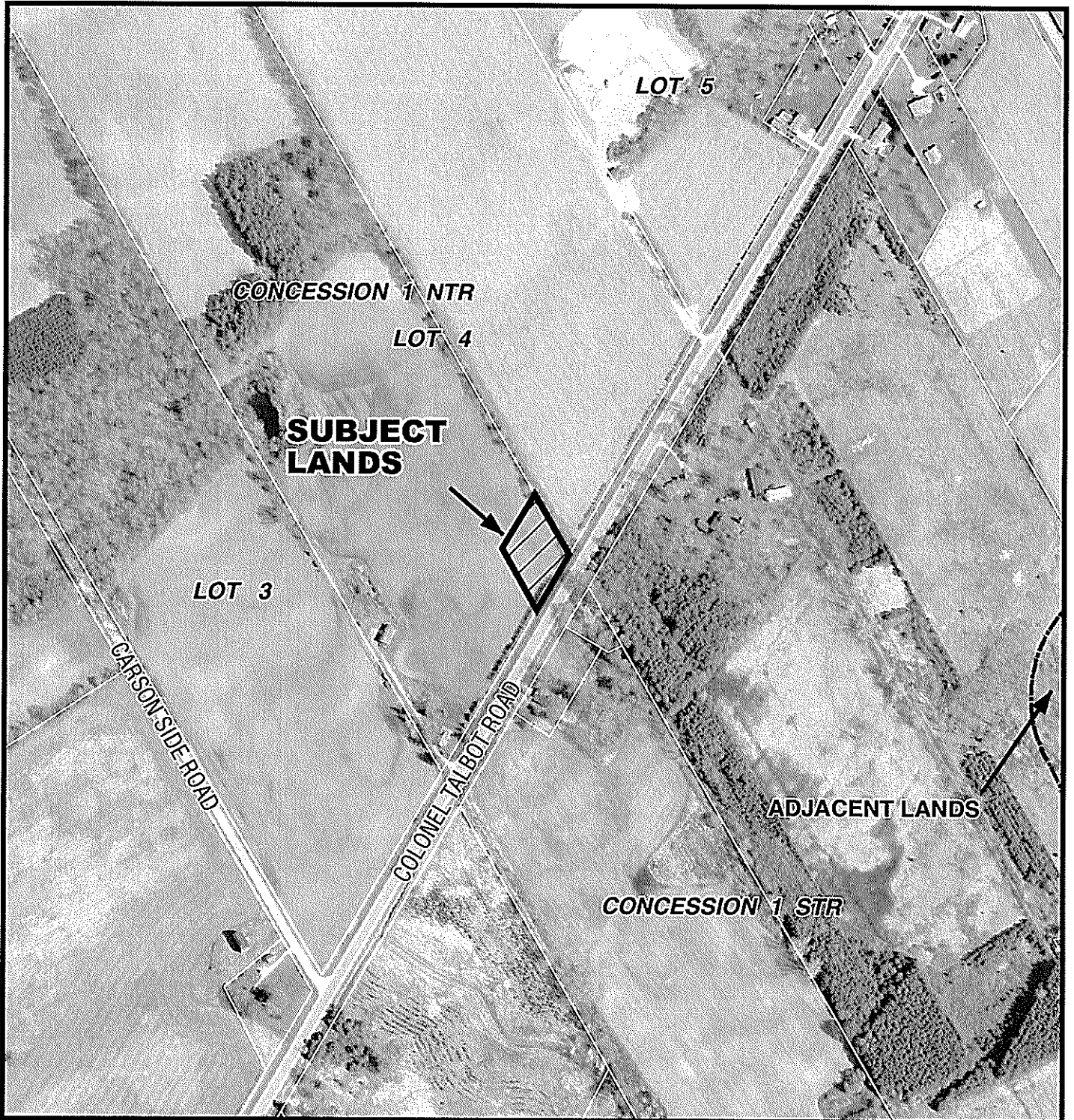
