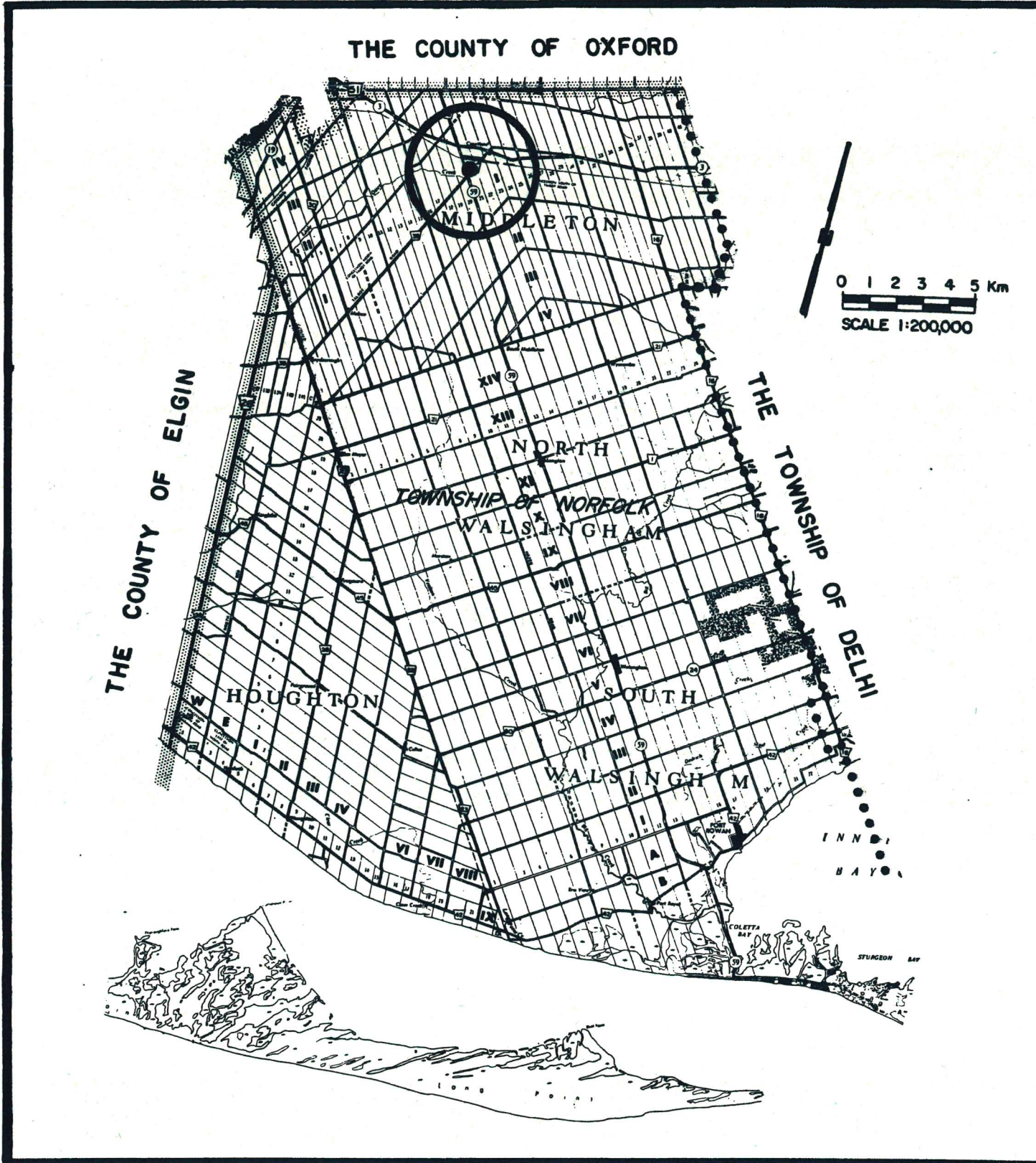

FORMER MUNICIPALITY: MIDDLETON



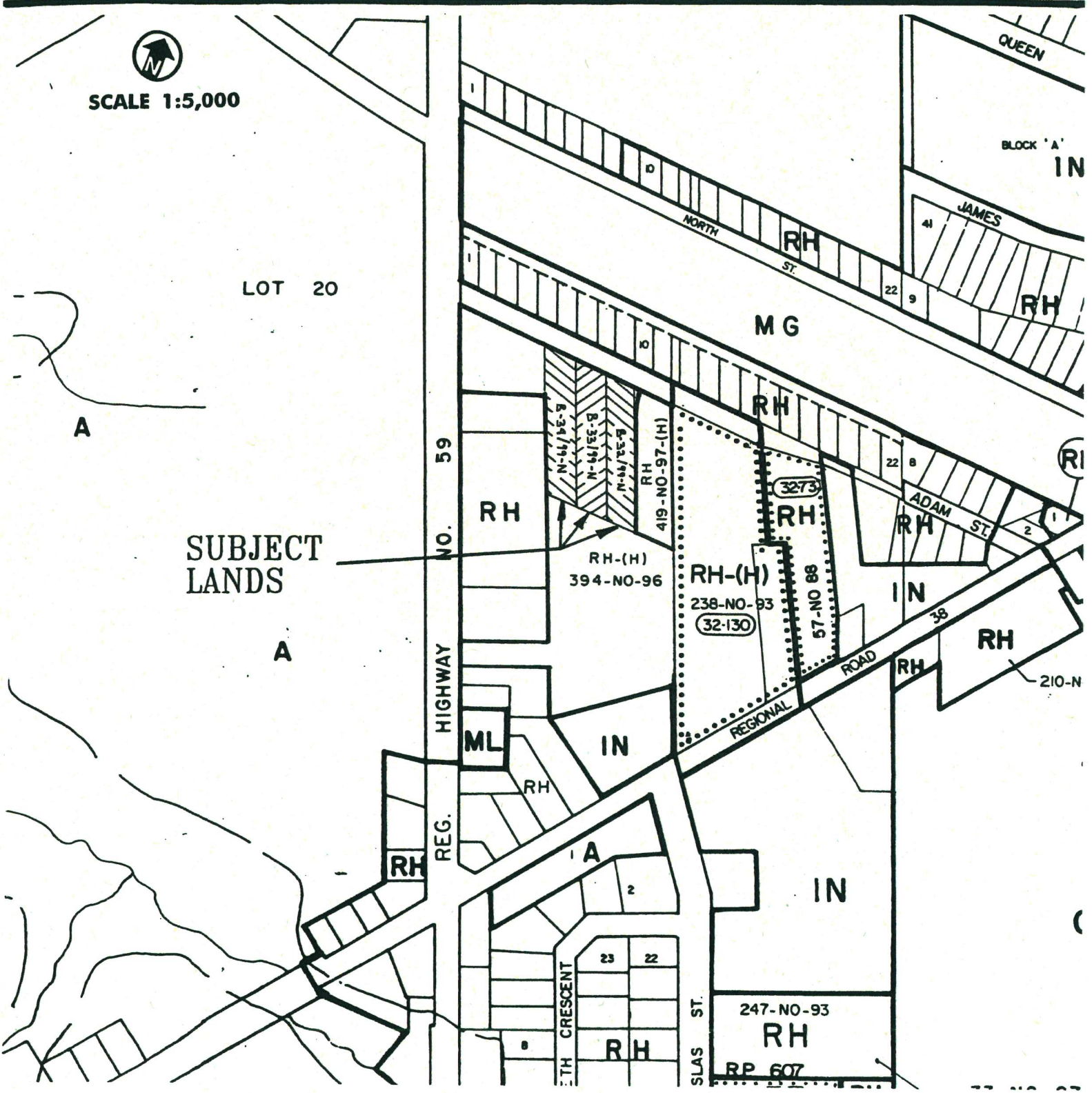
