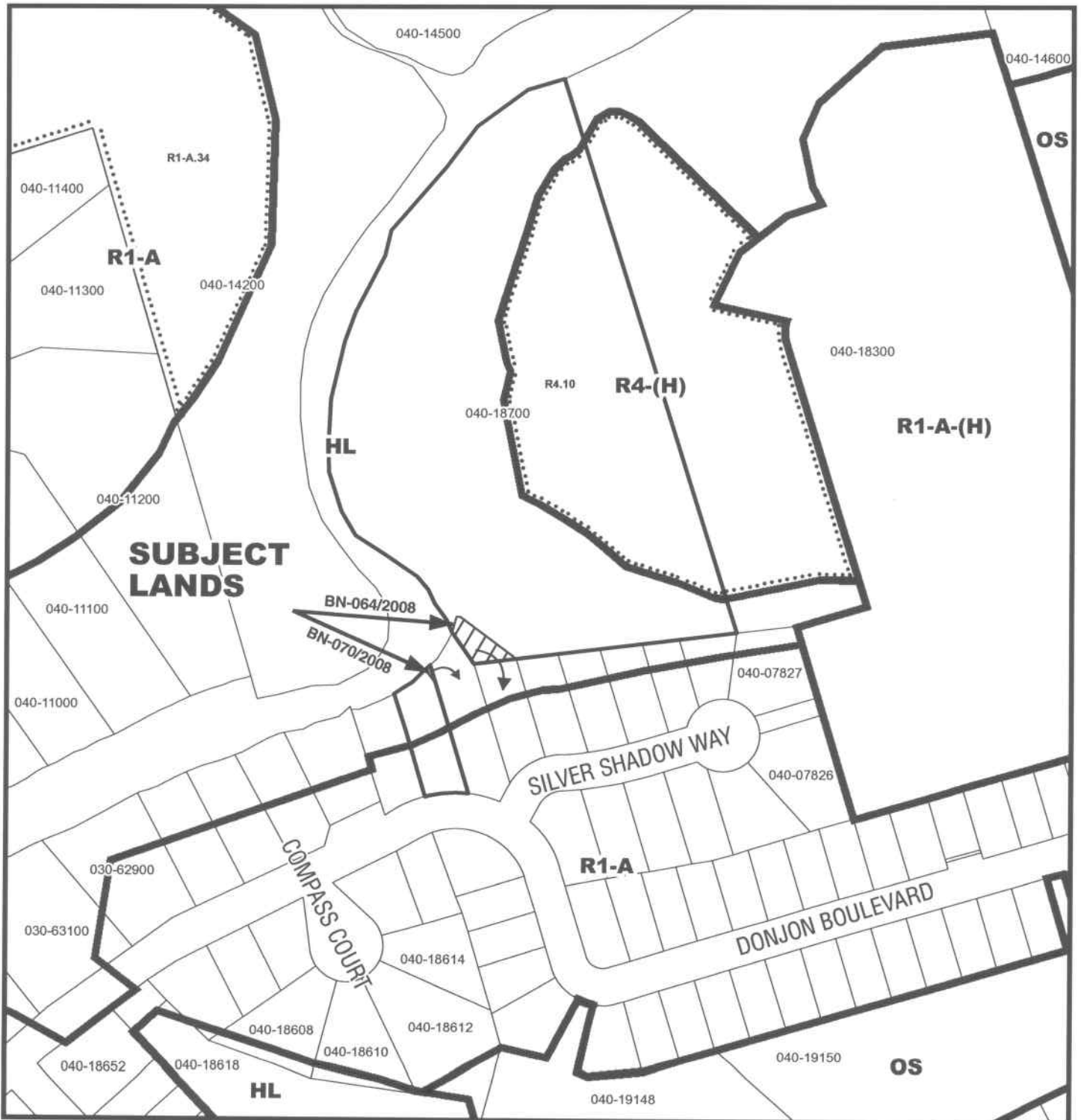
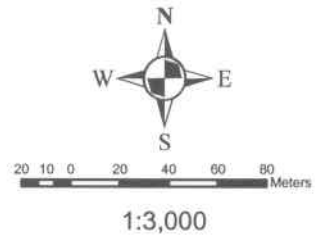


Lake Erie
