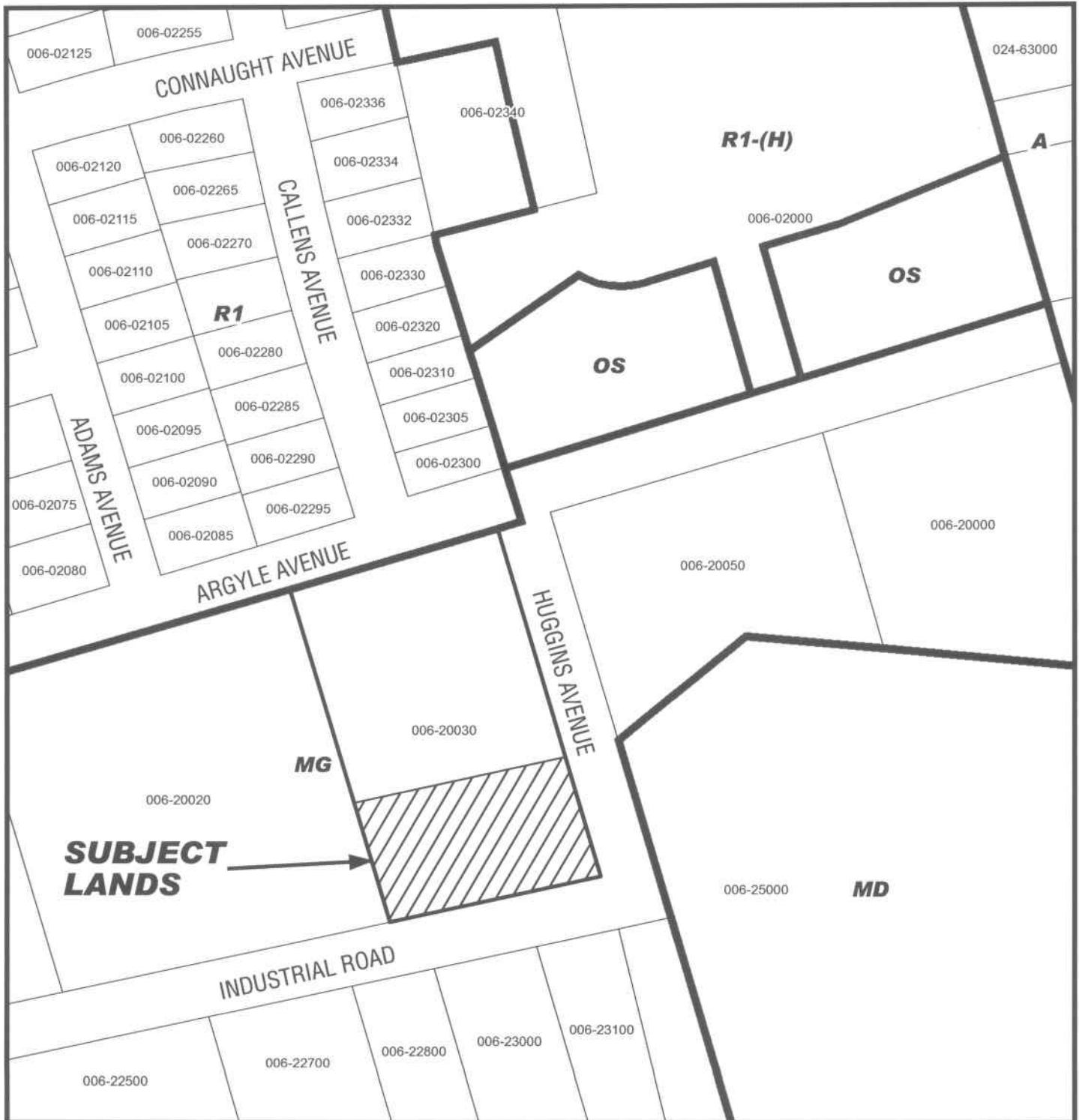
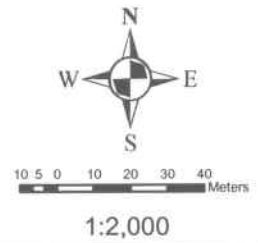
# MAP 1

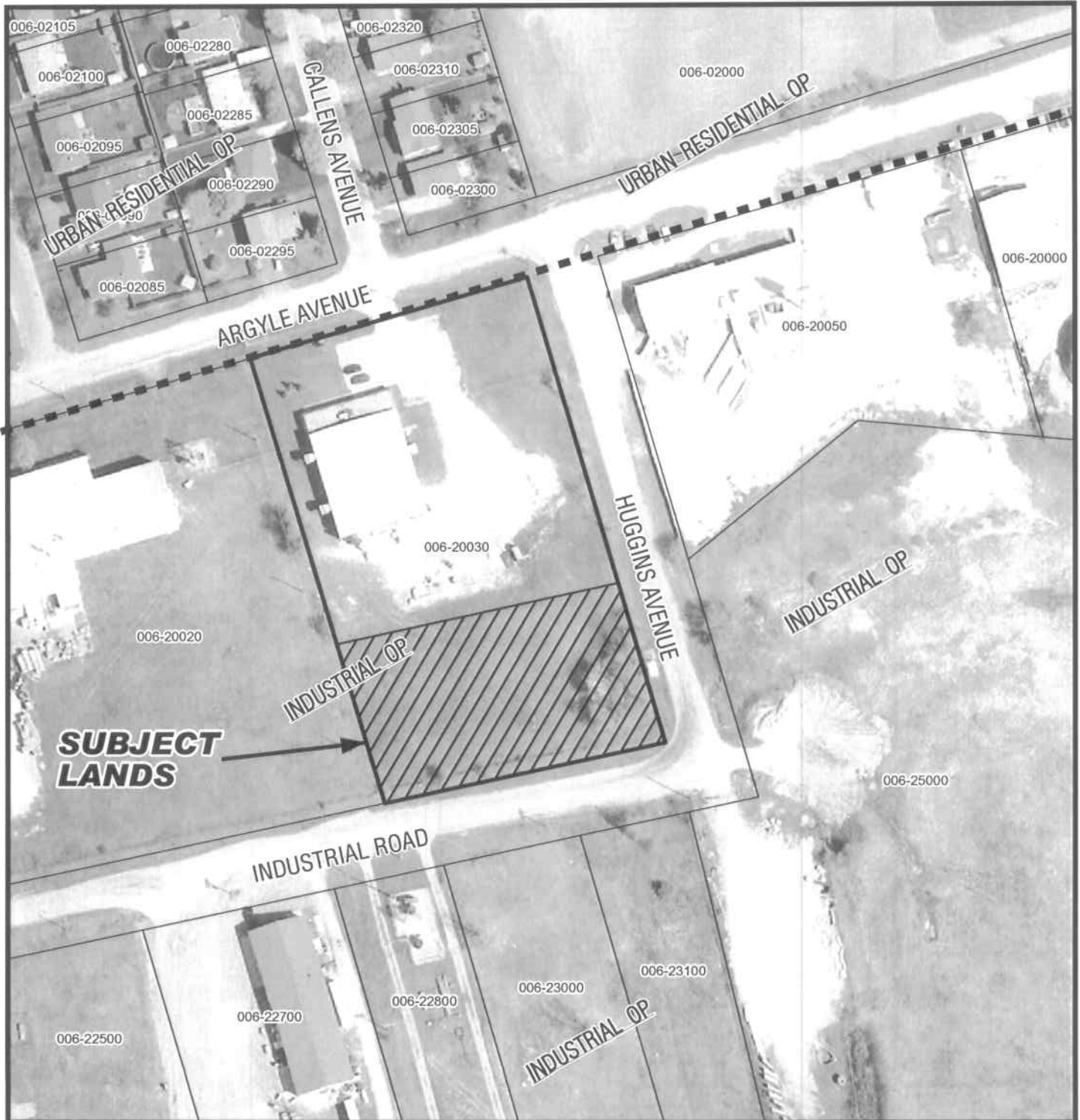
