Geographic Township of WINDHAM



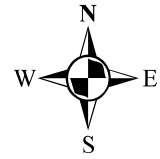

MAP 2

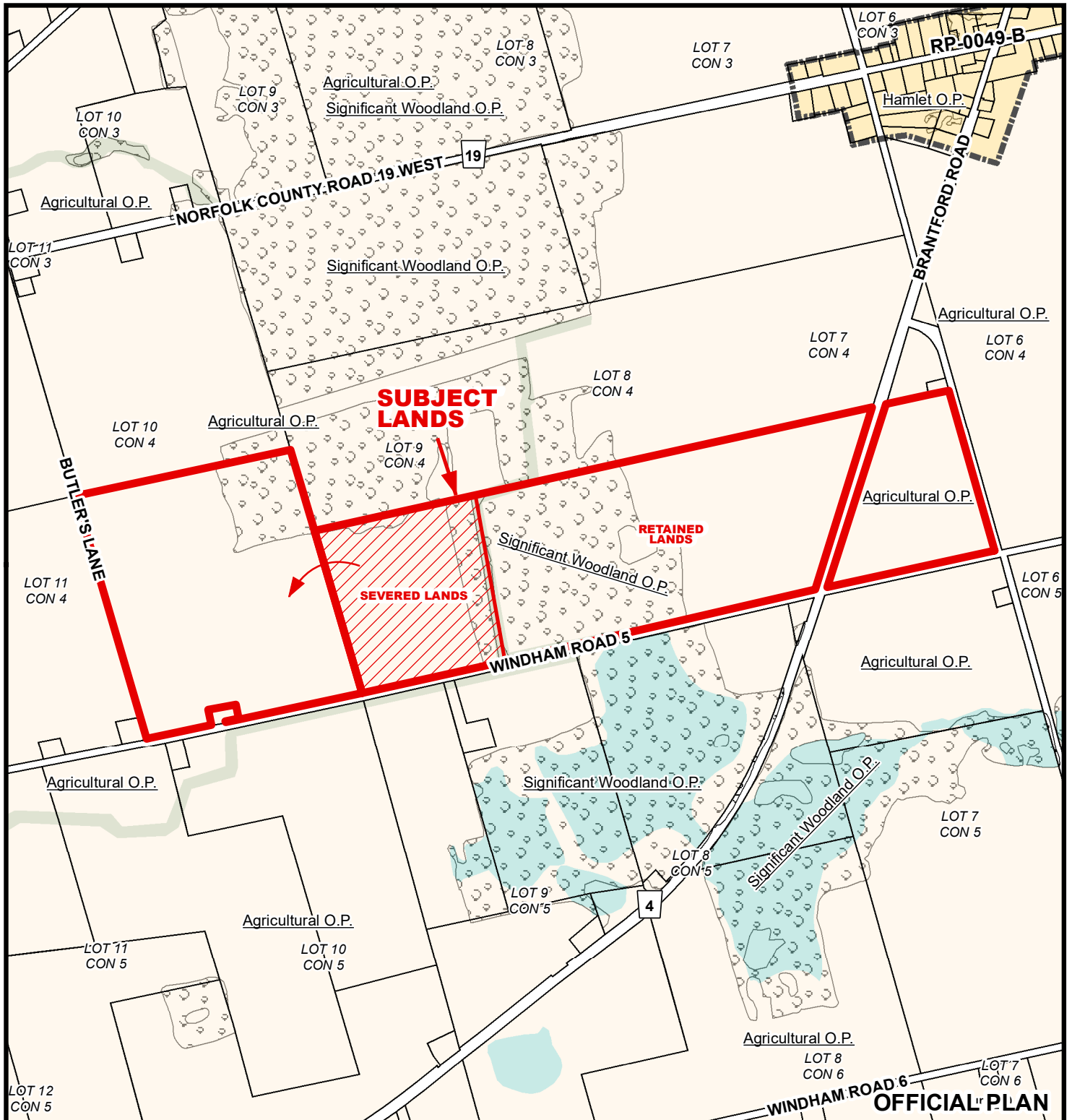

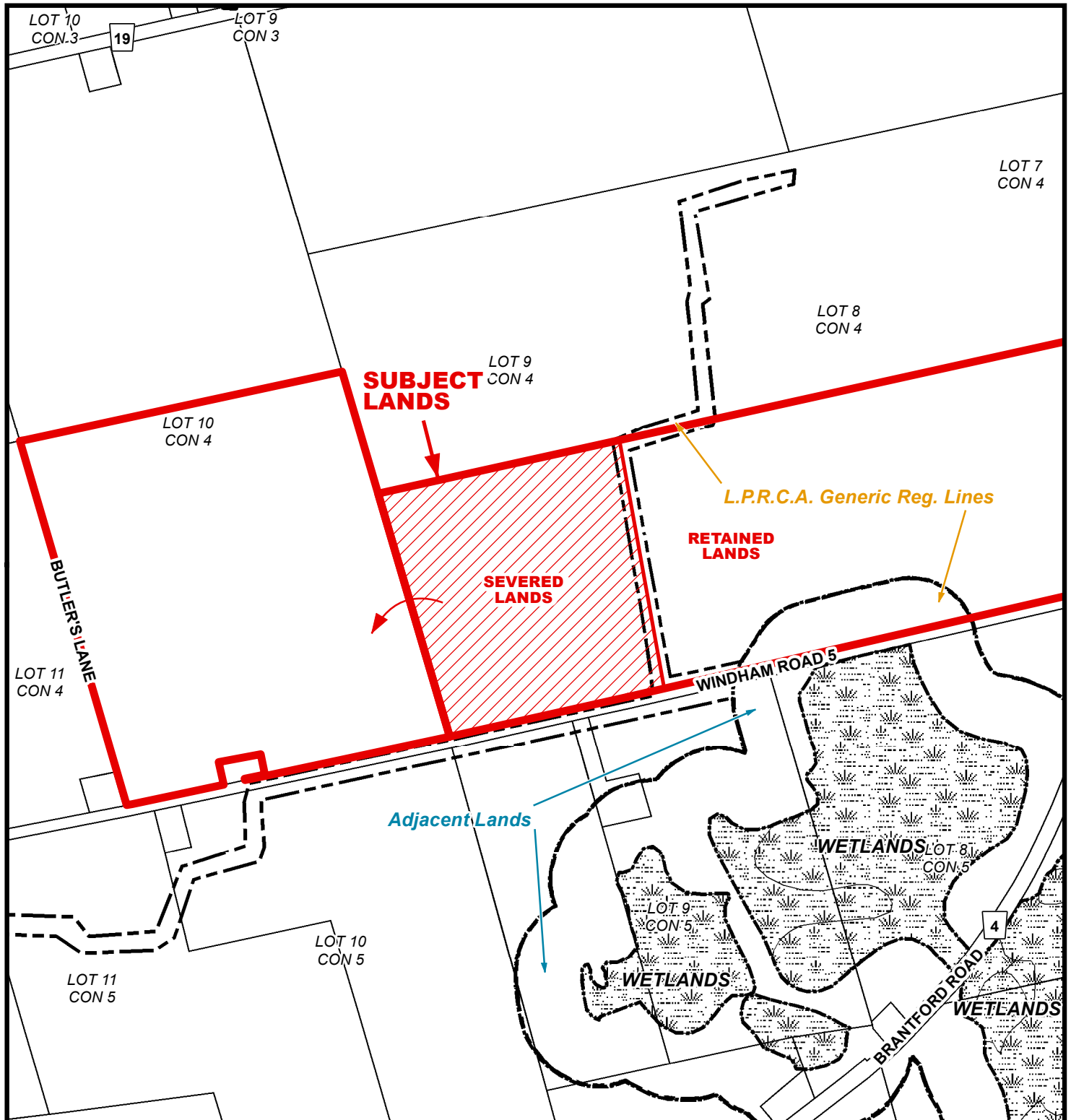
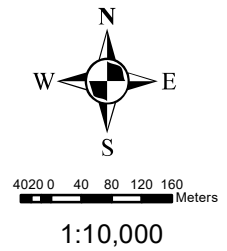
