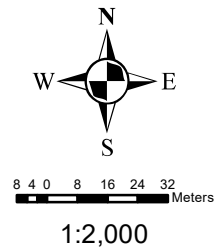
Urban Area of SIMCOE

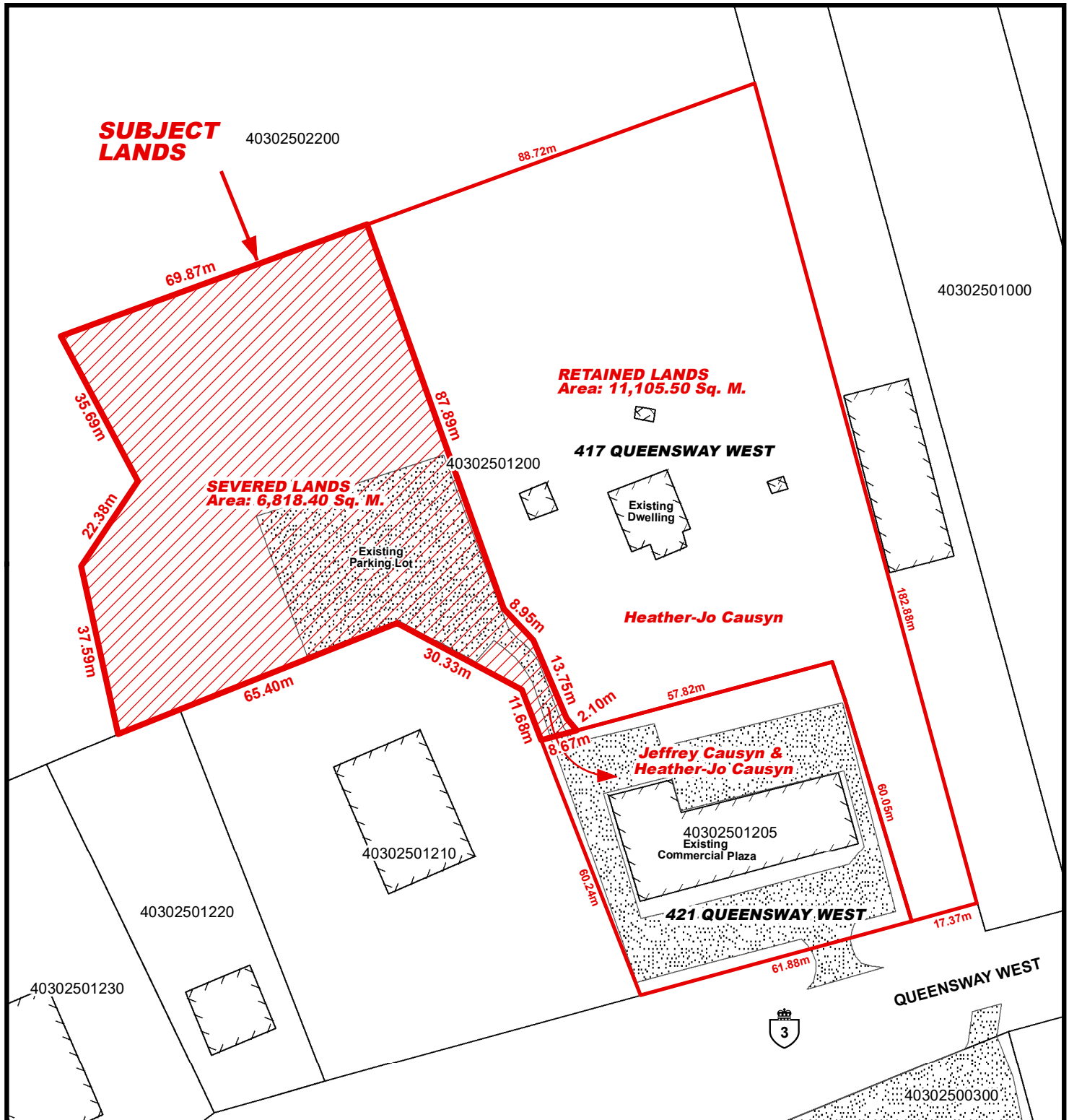
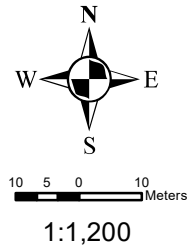
