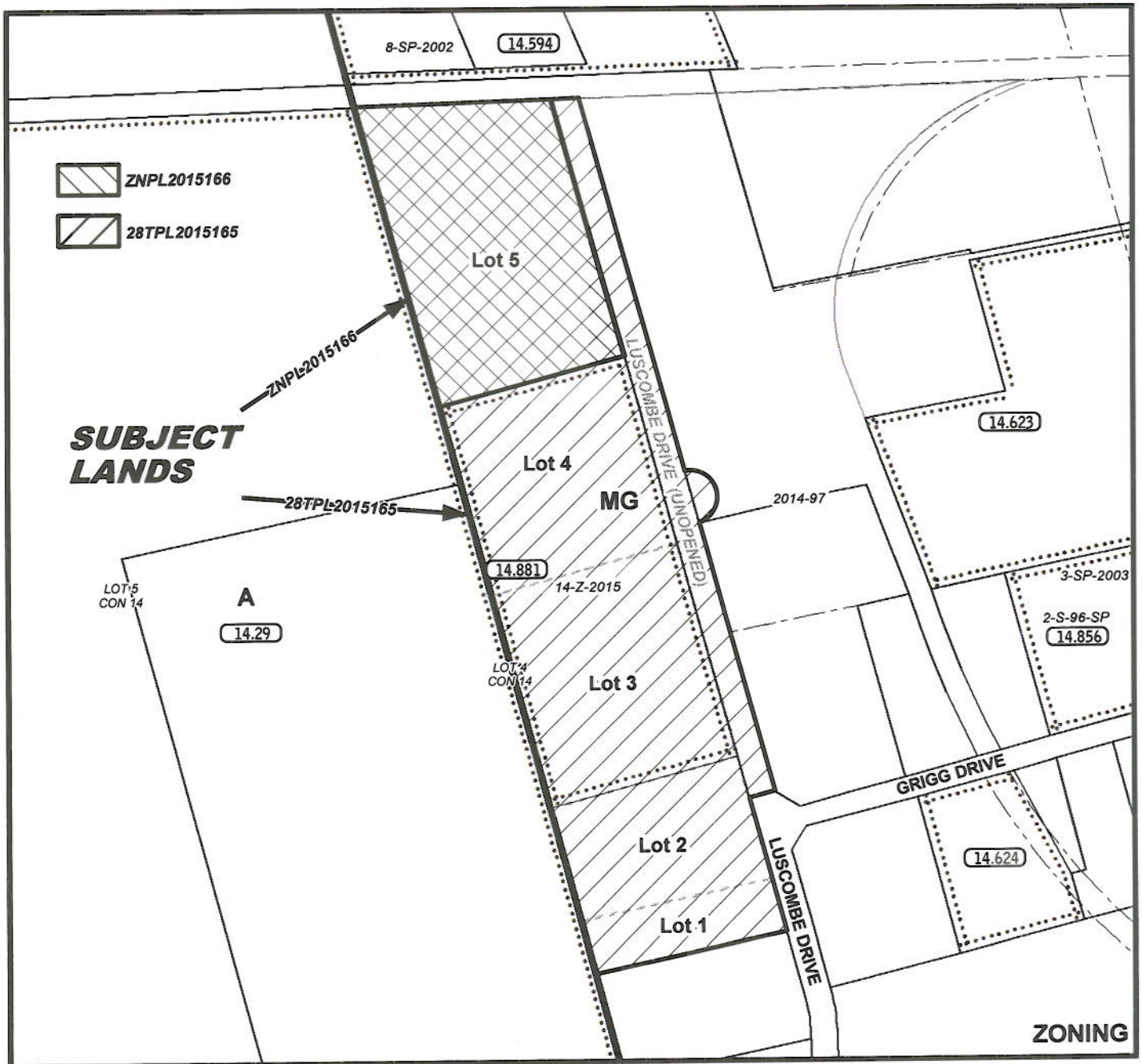
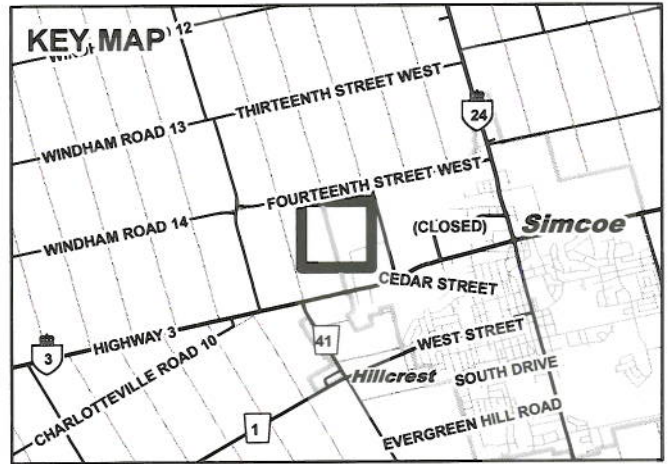
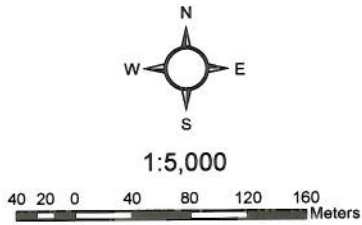

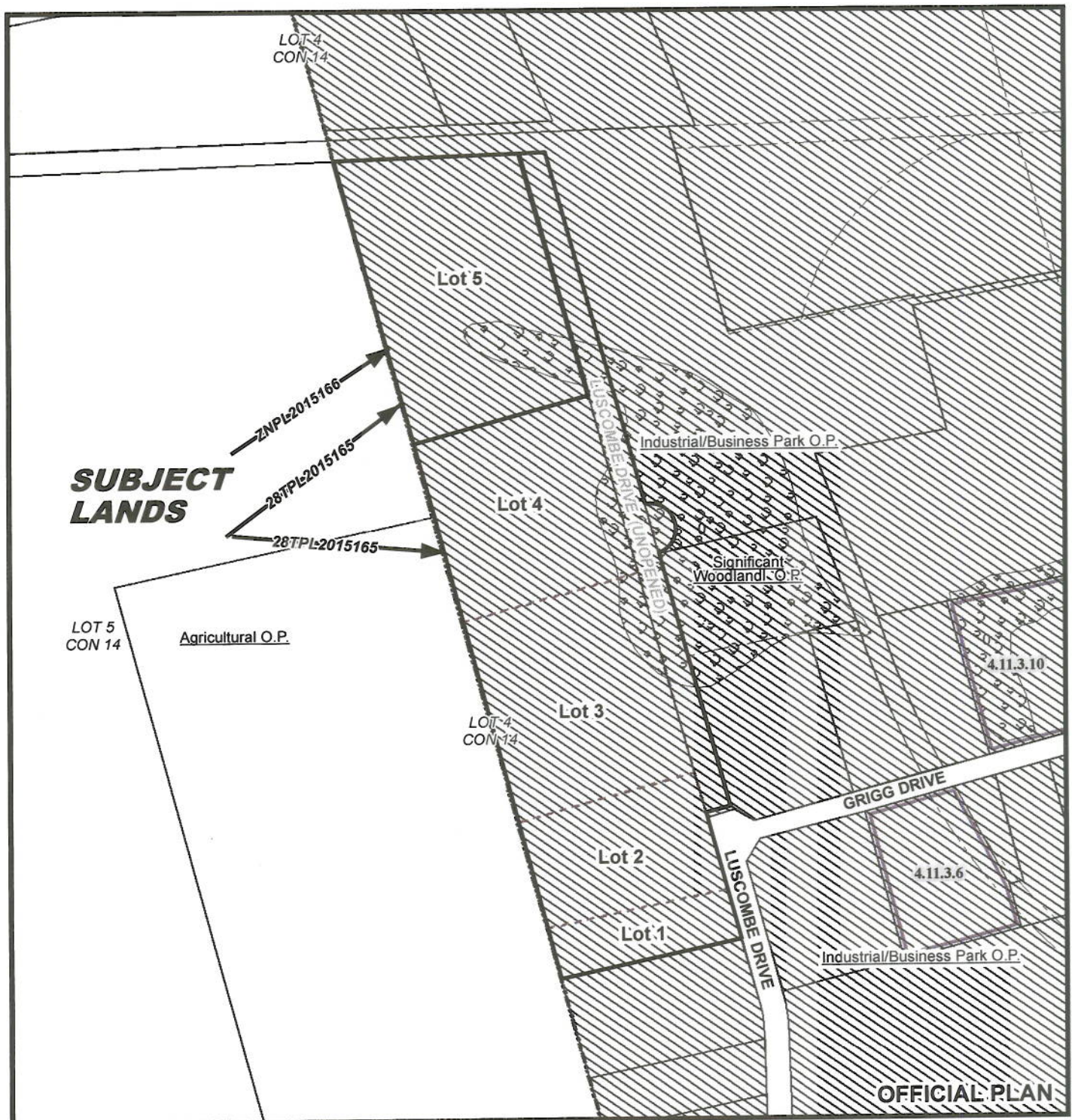
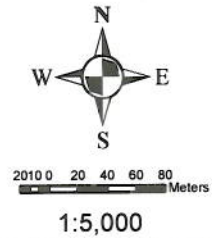
Urban Area of

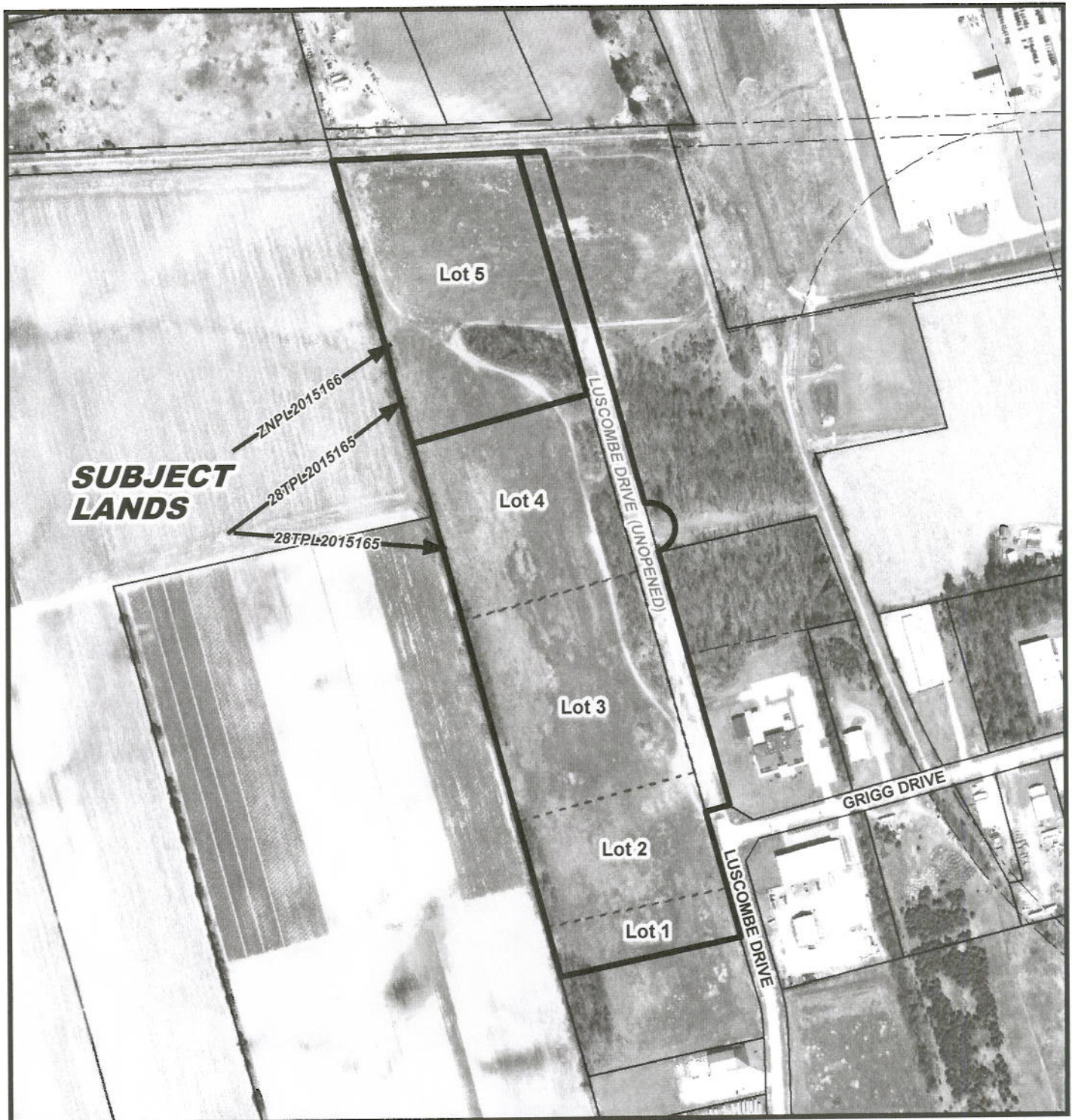
