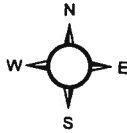

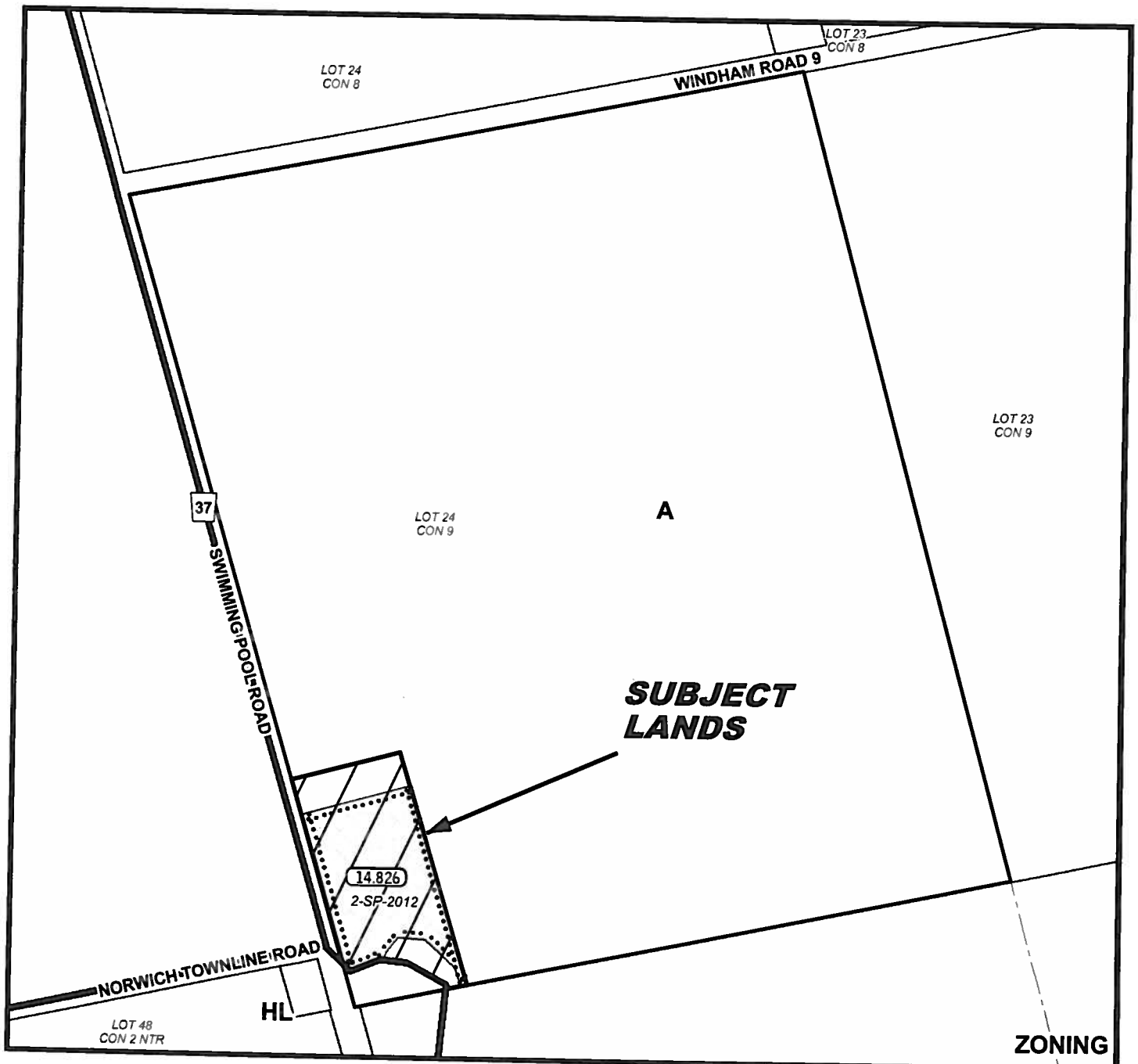

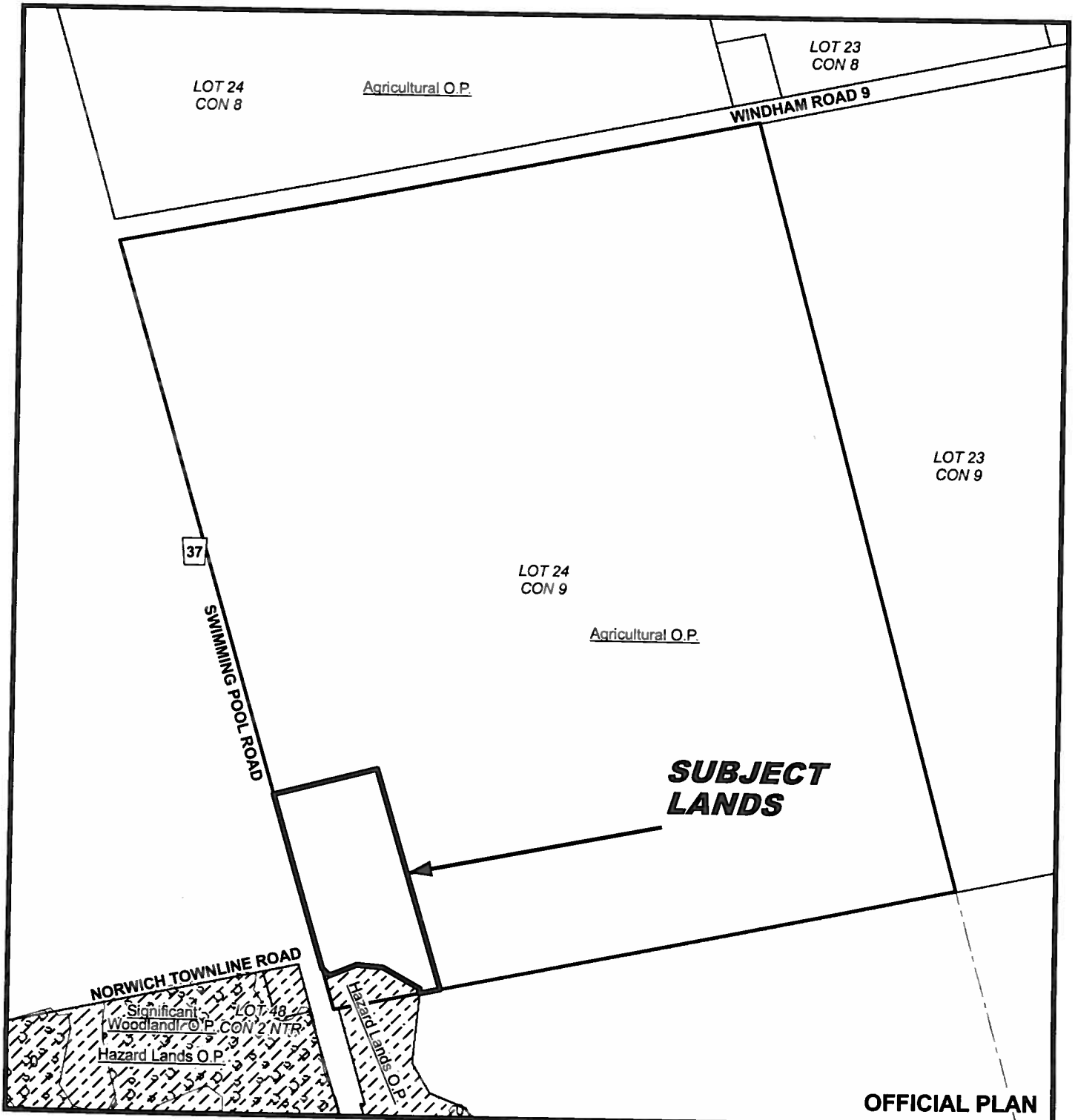

OFFICIAL PLAN

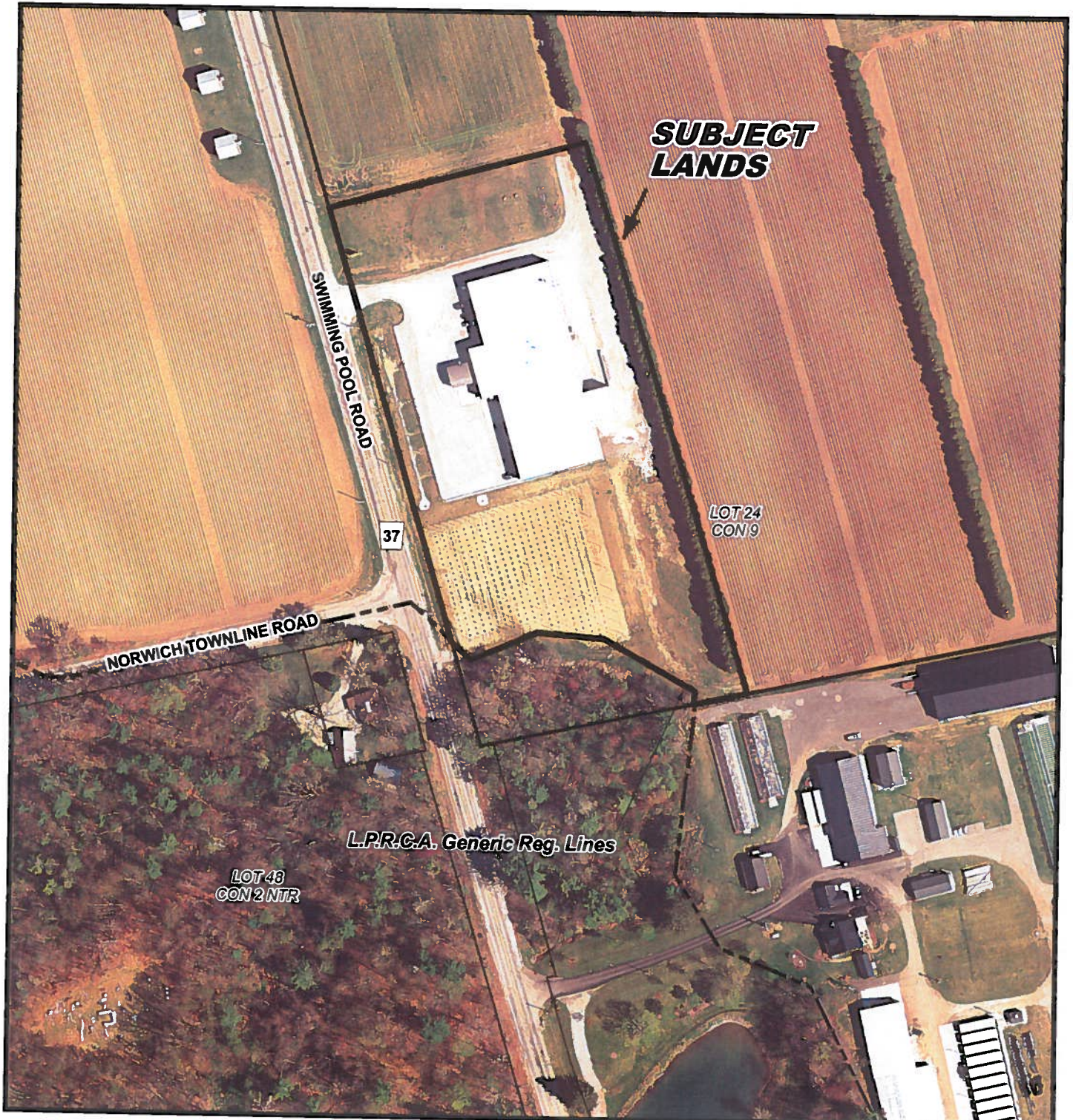
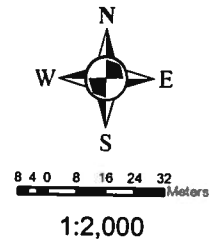

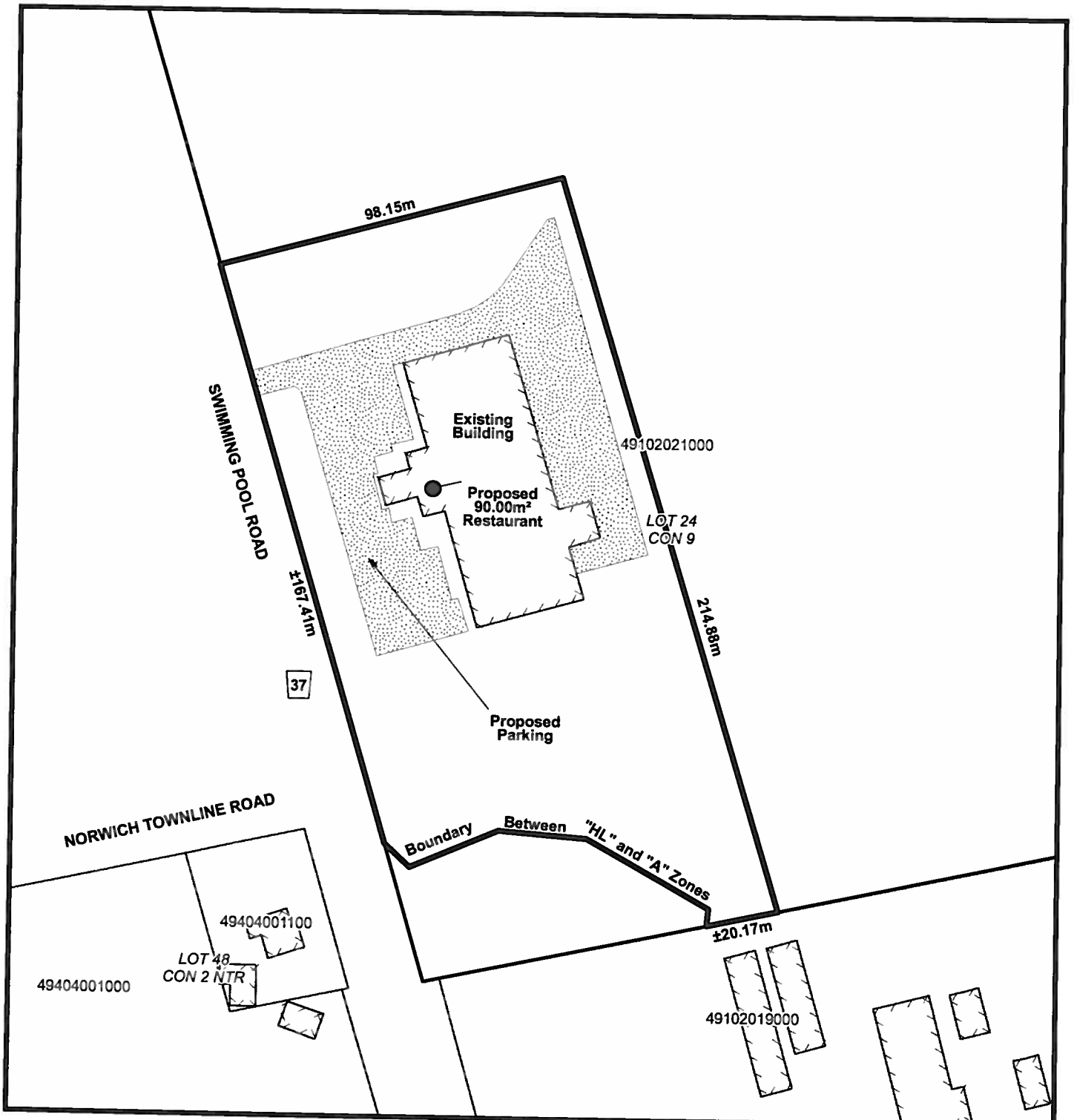
