4. Maintain the sign until the development application is finalized and thereafter removed

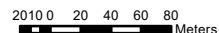

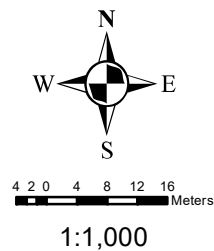

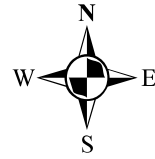
